### CONDITIONS FOR SPONSORING A PARADE IN VERNAL CITY:

1. All requirements imposed by the City for each respective parade shall be complied with by the parade sponsor and **all** participants.
2. The parade sponsor shall ensure that all parade participants conduct themselves in a safe and courteous manner during the course of the parade.
3. No obscene material or materials harmful to minors shall be allowed in the parade.
4. ***No items, including candy***, shall be distributed from entrants in the parade. Items may only be directly handed (from hand to hand) to persons viewing the parade from sidewalk locations.
5. The parade sponsor and monitoring officials shall restrict any parade entry from participating in the parade or continuing participation in the parade if such violations of any conditions imposed upon all parade entrants occurs.

6. The parade sponsor shall obtain a signed acknowledgment (as provided by the City) from each parade entrant acknowledging that the entrant will comply with all parade conditions and requirements as imposed by the City. Acknowledgments shall be presented to the City prior to the parade commencing.
  
7. The parade sponsor will provide one (1) parade official for every ten (10) entrants to monitor the entrants along the parade route to:
  - A. Ensure compliance with parade rules and requirements;
  - B. Recognize and correct safety hazards along the parade route; and,
  - C. Keep parade entrants moving evenly along the parade route.
