The advocacy program cannot end violence and crime, however our advocates and affiliates strive to provide awareness and education in our community. The advocacy program provides intervention and support to victims of violence.

### **Crisis Information:**

Advocates respond to your needs with the help of law enforcement at any time of the day or night. When law enforcement are called to an incident an advocate can be called to the scene, or the emergency room to assist the victim. Advocates can also call victims by phone to inform them of services provided by victim advocacy.

## OUR PROGRAM ALSO PROVIDES SUPPORT FOR...

Any victim of a crime that happened, in which the offender's case will be going through the Vernal City Justice Court.

We can notify you of court hearings, assist victims in meeting with the judge if a No Contact Order is requested, inform victims about victim impact statements, provide case information, help link victims with the city attorney at pre-trials, provide accompaniment during court, assist in getting restitution, inform victims of rights, educate and inform victims about the justice system.
