

A RESOLUTION OF THE VERNAL CITY COUNCIL AUTHORIZING THE EXECUTION OF AN AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN VERNAL CITY, NAPLES CITY, BALLARD CITY, AND UINTAH COUNTY AND THE UINTAH FIRE SUPPRESSION SPECIAL SERVICE DISTRICT WHICH TRANSFERS FIRE PROTECTION SERVICES OF THE VERNAL REGIONAL AIRPORT TO THE UINTAH TRANSPORTATION DISTRICT.

WHEREAS, pursuant to the provisions of the Interlocal Cooperation Act, Title 11, Chapter 13, Utah Code Annotated, 1953, as amended, public agencies, of the State of Utah including political subdivisions of the State of Utah as therein defined, are authorized to enter into mutually advantageous agreements for the purpose of providing governmental services; and

WHEREAS, the City's, the County and the District, through their respective governing bodies, have authorized this agreement after determining that the interests and welfare of the public will best be served by this Interlocal Cooperation Agreement to provide fire protection services; and

WHEREAS, it has been determined that the management of the airport will best be served by amending this agreement.

NOW THEREFORE, in consideration of the promises, representations and conditions set forth herein, the parties hereto agree as follows:

SECTION 1. AMENDMENT TO INTERLOCAL AGREEMENT. That the Vernal City Council desires to amend Article 7 of the Interlocal Agreement, revoking Article 7 in its entirety as the operation of the airport has been transferred to and assumed by the Uintah Transportation Special Service District. The parties further revoke all other references in the Amended Agreement regarding the airport.

SECTION 2. Approval. The Vernal City Council hereby approves the Amendment to the Interlocal Agreement referred to above and authorizes the Mayor to execute it on behalf of Vernal City.

SECTION 3. Severability. The provisions of this resolution shall be severable and if any provision thereof or the application of such provision under any circumstances is held invalid, it shall not affect any other provision of this resolution or the application in a different circumstance.


SECTION 4. Effective Date. This resolution shall become effective immediately upon adoption.

**AMENDMENT TO THE AMENDED INTERLOCAL AGREEMENT
FOR FIRE PROTECTION SERVICES**


Vernal City (hereinafter "Vernal"), Naples City (hereinafter "Naples"), Ballard City (hereinafter "Ballard"), Uintah County (hereinafter "County") and the Uintah Fire Suppression Special Service District (hereinafter "District") (herein referred to as parties) hereby amend the Amended Interlocal Agreement for Fire Protection Services which Amended Agreement has an effective date of September 1, 2014 as follows:

1. Revocation of Article Seven: The parties hereby revoke Article Seven Airport in its entirety as the operation of the airport has been transferred to and assumed by the Uintah Transportation Special Service District. The parties further revoke all other references in the Amended Agreement regarding the Airport.

2. Other Provisions: All other provisions of the Amended Interlocal Agreement for Fire Protection Services shall remain in full force and effect.
